NOTICE OF ANNUAL MEETING, BUDGET VOTE AND ELECTION
HONEOYE CENTRAL SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN, that a public hearing of the qualified voters of the Honeoye Central School District for the presentation of the budget for the fiscal year 2020-2021, in accordance with Executive Order 202.15, will be held remotely on Wednesday, May 27, 2020 at 6:30 PM via Google Meet with a link available on the district website at www.honeoye.org, The budget will be available for review on May 26, 2020 on the district website at www.honeoye.org, and at the District Office, 8528 Main Street, Honeoye, New York.

NOTICE IS HEREBY GIVEN, that pursuant to Executive Order 202.26, the Annual Meeting and Election [hereinafter “Annual Meeting”] of the qualified voters of the Honeoye Central School District will be remotely held on Tuesday, June 9, 2020. Voters will vote exclusively via absentee ballots. All ballots must be received in the Honeoye Central School District Office no later than 5:00 PM on June 9, 2020:

- 1) To adopt the annual budget of the School District for the fiscal year 2020-21, and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
- 2) To elect two (2) members of the Board of Education each for a three (3) year term commencing July 1, 2020, and expiring on June 30, 2023, to succeed Jessica Green and Sandra Hubble whose terms expire on June 30 of this year.

AND FURTHER NOTICE IS HEREBY GIVEN, that candidates for the office of member of the Board of Education can self-nominate with the Clerk of said School District at the Honeoye Central School District Office, no later than 5:00 pm on Monday, May 11, 2020. Candidates must meet School Board Member qualifications. The District shall fill such vacant seats at large with the candidates receiving the most votes.

AND FURTHER NOTICE IS HEREBY GIVEN that a list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District during each of the five (5) days prior to the Annual Meeting, except Saturday and Sunday, during regular office hours until the day of the .

AND FURTHER NOTICE IS HEREBY GIVEN, that absentee ballots shall be automatically mailed to all qualified voters of the District. A qualified voter is one who is (1) a citizen of the United States of America, (2) 18 years of age or older, and (3) resident within the School District for a period of thirty (30) days preceding the Annual Meeting. A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District during each of the five (5) days prior to the Annual Meeting, except Saturday and Sunday, during regular office hours until the day of the Annual Meeting.
